REPORT OF THE GENDER AUDIT, 2023 PERIOD – 2018-19 TO 2022-2023

PREAMBLE

Gender Audit of educational institutions is a process for organisational assessment and a tool for action planning from a gender perspective. It critically examines the capacity of institutions to ensure a 'safe and secure' ambience for women and girl students, faculty and administrative staff. The participatory audit process helps to identify institutional strengths and challenges to integrating gender, as well as gender equity, in the institution's systems and operations and in programmes and activities. Gender audit encourages the stakeholders in an educational institution to engage in a dialogue and reflect about the strengths and gaps of the system vis-à-vis gender related issues.

According to UN Sustainable Development Goal 5: Gender equality, gender auditing helps institutions to focus on such areas as:

- ♣Mainstreaming gender as a cross-cutting concern within the unit's objectives, programmes and budget.
- ♣Existing gender expertise and competence
- ♣Information and knowledge management on gender issues.
- **↓**Systems and instruments in use for accountability, evaluating and monitoring on gender equality.
- **↓**Staffing and human resources concerning balance between women and men, as well as gender-friendly policies.
- Organisational culture and its effects on gender equality.

GOVERNMENT GIRLS' GENERAL DEGREE COLLEGE as an institution is committed to equity and equality of opportunity. It also aims to offer quality education to all students irrespective of disparities in background. To fulfil its aims the College decided to go for a Gender Audit and hence this study, which has been carried out by applying the participatory methodology. Towards this end, I made two visits (Online and onsite both applicable) to GOVERNMENT GIRLS' GENERAL DEGREE COLLEGE and had interactive sessions with the teachers, staff and students of the College on the College premises. With the cooperation of the Principal, teachers and students of the College I was able to visit the various facilities and structures of the College premises and examine them in relation to their gender quotient. I also examined various

GIVEN BELOW IS A BRIEF PROFILE OF

GOVERNMENT GIRLS' GENERAL DEGREE COLLEGE:

Government Girls' General Degree College is the fourth Government college for girls in West Bengal. Due to its proximity to National Library, Calcutta University Alipur Campus, and other major locations of southern Kolkata, the college is favourably accessible to a large section of students interested in higher education. The establishment of this college marks a positive and progressive initiative towards facilitating higher education for women in West Bengal. Incidentally, the college was established after a decade long pressing demand for a Women's college in the locality. The college was inaugurated on the 28th January, 2016 by Honourable Chief Minister Smt. Mamata Banerjee. The College has been affiliated to the University of Calcutta. The inauguration inevitably marked the beginning of a journey towards achieving academic excellence for women. Presently, the college offers Honours Courses in Arts, Science and Commerce streams. Faculties of all fourteen departments (Honours) put untiring efforts to provide quality academic guidance to all students and work towards their overall developments.

The college began its academic journey on 28th January 2016 with fifteen departments. The academic session started with one hundred and fifteen students in both Arts and Science streams. To create awareness, conviction and commitment among the students towards social and moral values, the college arranges for compulsory Value Education classes where lectures are delivered by eminent personalities from various fields. The college provides scope to its students to put forward their views, positive and negative, through Grievance Redressal Cell and Anti-Ragging cell. The Psychological Counselling Cell looks into the problems faced by the students. Being a girl's college a Sexual Harassment Cell has also been set up within the campus.

Importance of Gender audit

A gender audit is required to be performed in every institute on a regular basis. It is a tool to assess and check the institutionalisation of gender equality into organisations, including in their policies, programmes, projects and/or provision of services, structures, proceedings and budgets

In this college a Gender Equity Cell has been formed and is acting with the objective to ensure equal opportunities to all stakeholders irrespective of gender biasness.

The college has taken efforts to conduct an intra-level gender audit by running a structured questionnaire among all the stakeholders (students, teachers and non-teaching members) in the college on different issues. The responses as received were anlaysed further. Further to mention that since the college is a girls college hence the students are 100% girls.

Annual gender sensitization action plan


IT INFRASTRUCTURE

SCHOLARSHIP FACILITIES AVAILABLE



- **8.** Also suggest that more female students be encouraged to participate in sports and to contest for college-level leadership positions.




